In that way we can 'live twice': once through our actions whilst we are alive and once though the legacy we leave, enabling others to follow our example for many years to come.

UJIA encourages the British Jewish community's young people to treasure their connection to the Jewish people by forging their own personal relationship with Israel, past present and future.

By leaving a legacy gift to UJIA you honour the generations of the past, and create a lasting imprint. The impact of your legacy will be felt on countless young Jews who, in many cases, are not even born yet and who are still to begin their relationship with Israel and the Jewish people. Leaving a legacy gift to UJIA will keep your memory alive and create a connection between you and the Jewish people that will live forever.

WHY SHOULD I REMEMBER A CHARITY IN MY WILL?

A gift to a charity is not only an incredible legacy to leave, it is also an exceptionally tax efficient one.

Charity legacies can 'cost' your loved ones just a fraction of the amount you leave, as a result of a reduced rate of Inheritance Tax on charity legacies, where at least 10% of your estate passes to charity. Let's have a look at an example. Say there is a taxable estate of £1 million (that is after deducting the Inheritance Tax free allowances passing to family). Look at the two scenarios opposite. In **SCENARIO A**, with no charity legacy, the full taxable estate is charged at the higher rate of tax, 40%. In **SCENARIO B**, the donor has left 10% (£100,000) to charity, which reduces the IHT rate to just 36%, so the legacy has only depleted the family's legacy by £24,000. Effectively the taxman has picked up the other £76,000 for you. Legacies are the single most tax efficient way of giving to charity.


